### EXECUTIVE ORDER NUMBER 19-47

WHEREAS, the Honorable AMIRA D. FOX, State Attorney for the Twentieth Judicial Circuit of Florida, has advised Governor RON DESANTIS that Jay B. Rosman has filed an affidavit to expunge/seal an arrest report; and

WHEREAS, The Honorable ED BRODSKY, State Attorney for the Twelfth Judicial Circuit of Florida handled the original case involving Jay B. Rosman under Executive Order 18-45; and

WHEREAS, the Honorable AMIRA D. FOX has also advised the Governor that the original conflict continues to exist as Jay B. Rosman is a sitting judge in the Twentieth Judicial Circuit; and

WHEREAS, the Honorable AMIRA D. FOX, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified herself and has requested the executive assignment of another State Attorney with respect to the investigation and prosecution of this case and all related matters; and

WHEREAS, the Honorable ED BRODSKY, State Attorney for the Twelfth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable ED BRODSKY discharge the duties of the Honorable AMIRA D. FOX, pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RON DESANTIS, Governor of Florida, in obedience to my solemn constitutional duty to “take care that the laws be faithfully executed,” and pursuant to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1.

The Honorable ED BRODSKY, State Attorney for the Twelfth Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable AMIRA D. FOX, State Attorney for the Twentieth Judicial Circuit of Florida, as they relate to the investigation, prosecution, and all matters related to Jay B. Rosman.

Section 2.

The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Twentieth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3.

All residents of the Twentieth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4.

The period of this Executive Assignment shall be for one (1) year, to and including February 22, 2020.

Section 5.

The Assigned State Attorney shall notify the Governor on or before January 22, 2020,  
if additional time is required.
