I believe it is now my responsibility to be by their side and care for them in the waning days of their lives.



I do want to express my utmost gratitude to State Attorneys John Tanner and Steve Alexander for giving me the opportunity to serve the people of the State of Florida as an Assistant State Attorney for 15 years. I also wish to thank Governor Jeb Bush for giving me the vote of confidence in appointing me Circuit Judge – a career that lasted 18 years of my life. I also wish to thank the people of the Seventh Judicial Circuit, especially the thousands of jurors who served in the many trials I prosecuted or presided over the many years.
