- 2) The application, which can be downloaded from the Florida Bar website (www.flabar.org) or Governor Ron DeSantis's website https://www.flgov.com/judicial-and-judicial-nominating-commission-information/, must include:
 - One (1) Digital (electronic) copy of the application (either as a .PDF or in Microsoft Word), and One (1) Digital (electronic) copy of the application (either as a .PDF or in Microsoft Word) with personal information redacted as permitted by Section 119.071, Florida Statutes in a format suitable for production in response to a public records request.
- 3) To assist the Commission, all questions on the application must be fully and completely answered.
- 4) Applications must include current contact information (especially direct phone numbers), including e-mail addresses for judges, co-counsel, opposing counsel, and references to facilitate the background investigation that will be conducted by the members of the commission.

- 5) A recent photograph should be attached to the original and the copy;
- 6) All letters of recommendation in your possession that you wish the Commission to consider. Recommendations may also be sent as supplements after the application is submitted. The Commission prefers that letters be scanned and emailed to the above email addresses given time constraints;
- 7) Copies of the applicant's completed Federal Income Tax Returns for the preceding three (3) years OR the completed Financial History and Form 6 contained in the application. NOTE: if you are practicing law as a professional association, your tax returns for the three (3) year period should include the tax returns for the professional association; (These shall be transmitted electronically together with the original of the application.)
- 8) Any additional information which you feel may be helpful to the Commission in assessing your qualifications
- 9) After the deadline for submitting applications, the Commission will determine which applicants to interview. If you are to be interviewed, you will be contacted to confirm the date, time and location.
- 10) Proceedings of the Commission are open to the public except for deliberations. Accordingly, you should not expect the fact that you have applied to be kept confidential.
- 11) If an applicant is nominated, all materials attached to the original application will be submitted to the Governor.
