BREVARD COUNTY**

NOTICE: The 18th Circuit Judicial Nominating Committee announces a vacancy in the Circuit Court of Brevard County to fill the vacancy created by the retirement of Circuit Judge Tonya Rainwater effective midnight, July 12, 2019.

REQUIREMENTS: Applicants must have been a member of the Florida Bar for the preceding five (5) years, a registered voter, and must be a resident of the territorial jurisdiction of the court at the time he or she assumes office. Applicants must meet the qualifications for Circuit Court Judges described in Article V, Section 8 of the Florida Constitution.

All persons interested in applying must deliver:

2. One **complete** copy with all attachments in electronic form by email to alan@alandmanpa.com.

One (1) **redacted** .pdf version of the application only (not incl. attachments) by email to alan@alandmanpa.com excluding all exempt information under Chapter 119, F.A. and other applicable public records law. EXTENDED DEADLINE: The deadline for submission of the application **has been extended to 5 p.m. on Monday, 4/15/19**. Any application delivered after the deadline will not be considered.

INTERVIEWS: Interviews are scheduled to be held on **Tuesday, 4/23/19**. If an additional interview date is necessary due to the number of applications received, same will occur on **Friday, 4/26/19**. All interviews will be conducted at the Maxwell C. King Center, 3865 N Wickham Rd, Melbourne, FL 32935. **An interview schedule with the exact dates and times of each interview will be provided after the 4/15/19 application deadline.**
