BARTOW – The Tenth Circuit Judicial Nominating Commission has been asked to provide Governor Ron DeSantis with nominees for the vacancy on the Tenth Judicial Circuit, Circuit Court created by the resignation of **Judge Steven L. Selph**.

The Commission requests that interested candidates submit an application for consideration. Applicants must meet the qualifications for circuit court judges described in Article V, Section 8 of the Florida Constitution.

Applicants must submit two (2) copies of their application by **5:00 pm on Friday, March 26, 2021**, as follows:

(1): The original unredacted application shall be emailed in .pdf format to: lydia@southernatlanticlaw.com.

(2): A redacted .pdf of the application shall be emailed to lydia@southernatlanticlaw.com. Personal information not subject to public disclosure—such as the social security number—shall be redacted as permitted by Section 119.071 of the Florida Statutes.

Untimely applications will not be considered. The filename for .pdf applications should be as follows “21.03.26 FIRSTNAME LASTNAME Circuit Application (redacted /unredacted).”
