Any additional information that the applicant feels may be helpful to the Commission in assessing the applicant's qualifications shall be included as attachments to the original application and redacted copy saved in the .pdf file.

The Commission strongly suggests that applications be submitted as soon as they are prepared and well before the deadline. Applicants granted an interview will be scheduled in the order in which applications are received.
