OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 24-100 (State Attorney Executive Assignment)

WHEREAS, the Honorable JOHN F. DURRETT, State Attorney for the Third Judicial Circuit of Florida, has advised Governor RON DESANTIS that allegations have been made against Dustin Travis Beach for harassment/stalking; and

WHEREAS, the Honorable JOHN F. DURRETT has also advised the Governor that Dustin Travis Beach is the spouse of the Taylor County Property Appraiser in the Third Judicial Circuit; and

WHEREAS, the Honorable JOHN F. DURRETT, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney regarding the investigation and prosecution of this case and all related matters regarding Dustin Travis Beach; and

WHEREAS, the Honorable JACK CAMPBELL, State Attorney for the Second Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable JACK CAMPBELL discharge the duties of the Honorable JOHN F. DURRETT, pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RON DESANTIS, Governor of Florida, in obedience to my solemn constitutional duty to “take care that the laws be faithfully executed,” and pursuant to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1. The Honorable JACK CAMPBELL, State Attorney for the Second Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable JOHN F. DURRETT, State Attorney for the Third Judicial Circuit of Florida, regarding the investigation and prosecution of this case and all related matters regarding Dustin Travis Beach.

Section 2. The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Third Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3. All residents of the Third Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4. The period of this Executive Assignment shall be for one (1) year, to and including May 22, 2025.

Section 5. The Assigned State Attorney shall notify the Governor on or before April 22, 2025, if additional time is required.


