EXECUTIVE ORDER NUMBER 12-224

WHEREAS, the Honorable MARK A. OBER, State Attorney for the Thirteenth Judicial Circuit of Florida, has advised Governor RICK SCOTT that Cash Wilson Cannella has been charged with driving while license suspended with knowledge; and

WHEREAS, the Honorable MARK A. OBER has also advised the Governor that the Cash Wilson Cannella is a family friend of the state attorney; and

WHEREAS, the Honorable MARK A. OBER, to avoid any appearance of conflict of interest or impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney with respect to the investigation and prosecution of this case and all related matters; and

WHEREAS, the Honorable JERRY HILL, State Attorney for the Tenth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interest of the State of Florida and of the ends of justice that the Honorable JERRY HILL discharge the duties of the Honorable MARK A. OBER, pursuant to Section 27.14, Florida Statutes;

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant

to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1.

The Honorable JERRY HILL, State Attorney for the Tenth Judicial Circuit of Florida, referred to as the "Assigned State Attorney," is assigned to discharge the duties of the Honorable MARK A. OBER, State Attorney for the Thirteenth Judicial Circuit of Florida, as they relate to the investigation, prosecution and all matters related to Cash Wilson Cannella.

Section 2.

The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Thirteenth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3.

All residents of the Thirteenth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4.

The period of this Executive Assignment shall be for one (1) year, to and including October 4, 2013.

Section 5.

The Assigned State Attorney shall notify the Governor on or before September 4, 2013, if additional time is required.
