EXECUTIVE ORDER NUMBER 12-60

WHEREAS, the Honorable GLENN HESS, State Attorney for the Fourteenth Judicial Circuit of Florida, has advised Governor RICK SCOTT that Jimmy E. Stanford has been charged with driving while his license was suspended/revoked; and

WHEREAS, the Honorable GLENN HESS has also advised the Governor that Jimmy E. Stanford is a former law enforcement officer in the Fourteenth Judicial Circuit with which his office has a working relationship; and

WHEREAS, the Honorable GLENN HESS, to avoid any appearance of conflict of interest or impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney with respect to the investigation and potential prosecution of this case and all related matters; and

WHEREAS, the Honorable WILLIAM EDDINS, State Attorney for the First Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interest of the State of Florida and of the ends of justice that the Honorable WILLIAM EDDINS discharge the duties of the Honorable GLENN HESS, pursuant to Section 27.14, Florida Statutes;

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant

to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1.

The Honorable WILLIAM EDDINS, State Attorney for the First Judicial Circuit of Florida, referred to as the "Assigned State Attorney," is assigned to discharge the duties of the Honorable GLENN HESS, State Attorney for the Fourteenth Judicial Circuit of Florida, as they relate to the investigation, potential prosecution and all matters related to Jimmy E. Stanford.

Section 2.

The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Fourteenth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3.

All residents of the Fourteenth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4.

The period of this Executive Assignment shall be for one (1) year, to and including March 8, 2013.

Section 5.

The Assigned State Attorney shall notify the Governor on or before February 8, 2013, if additional time is required.
