## OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 12-77

WHEREAS, the people of the State of Florida, by constitutional amendment, have declared that a public office is a public trust and the people have a right to secure and sustain that trust against abuse; and

WHEREAS, the Commission on Ethics of the State of Florida has been created to represent the people in assuring that public officers do not abuse trust placed in them; and

WHEREAS, Peter D. Sleiman, is at all times material hereto a former member of the Board of Trustees for the Jacksonville Police and Fire Pension Fund, and as such was subject to the provisions of the Code of Ethics for Public Officers and Employees, Part III of Chapter 112, Florida Statutes, and within the jurisdiction of the State of Florida Commission on Ethics; and

WHEREAS, the Commission on Ethics concluded that Mr. Sleiman violated Section 112.3145, Florida Statutes, by failing to indicate a method of reporting and provide a more detailed description of properties on his CE Form 1, Statement of Financial Interests, for the years 2005, 2006, 2007, 2008, and 2009; and

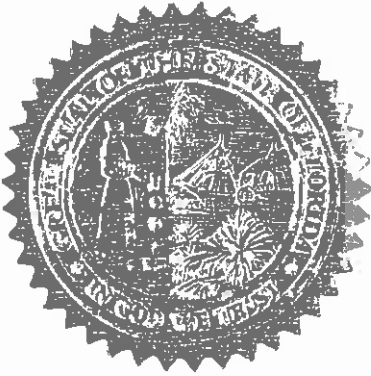
WHEREAS, the Governor accepts the findings, conclusions, and recommendations of the Commission on Ethics Final Order and Public Report dated February 8, 2012;

NOW THEREFORE, I, RICK SCOTT, Governor of Florida, in obedience to my constitutional duty to take care that the laws be faithfully executed, and pursuant to the Constitution and laws of the State of Florida, issue this Executive Order effective immediately finding that:

1. Peter D. Sleiman violated Section 112.3145, Florida Statutes, by failing to indicate a method of reporting and provide a more detailed description of properties on his CE Form 1, Statement of Financial Interests, for the years 2005, 2006, 2007, 2008, and 2009.

2. A civil penalty in the amount of \$2,500.00 is hereby imposed against Mr. Sleiman, which penalty shall be satisfied within thirty (30) days of the date of this order. Payment must be submitted with a written statement made under oath by Mr. Sleiman that the penalty was not paid with public funds and will not be reimbursed with public funds.


FINAL ORDER AND PUBLIC REPORT

The State of Florida Commission on Ethics, meeting in public session on Friday, February 3, 2012, adopted the Joint Stipulation of Fact, Law and Recommended Order entered into between the Advocate for the Commission and the Respondent in this matter. In accordance with the Stipulation, which is attached hereto and incorporated herein by reference, the Commission finds that the Respondent, who served on the Board of Trustees for the Jacksonville Police and Fire Pension Fund, violated Section 112.3145, Florida Statutes, by failing to indicate a method of reporting and provide a more detailed description of properties on his CE Form 1 for the years 2005, 2006, 2007, 2008, and 2009.

For these violations, the Commission hereby recommends that the Respondent be ordered to pay a civil penalty of \$2,500.
