EXECUTIVE ORDER NUMBER 12-82

WHEREAS, the Honorable BRUCE H. COLTON, State Attorney for the Nineteenth Judicial Circuit of Florida, has advised Governor RICK SCOTT that Amanda R. (Wilson) Montenegro was arrested for possession of alprazolam and seven counts of possession of morphine; and

WHEREAS, the Honorable BRUCE H. COLTON has also advised the Governor that Amanda R. (Wilson) Montenegro is the daughter of the chief deputy of the St. Lucie County Sheriff's Office, with whom he has worked closely; and

WHEREAS, the Honorable BRUCE H. COLTON, to avoid any appearance of conflict of interest or impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney with respect to the investigation and potential prosecution of this case and all related matters; and

WHEREAS, the Honorable STEPHEN B. RUSSELL, State Attorney for the Twentieth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interest of the State of Florida and of the ends of justice that the Honorable STEPHEN B. RUSSELL discharge the duties of the Honorable BRUCE H. COLTON, pursuant to Section 27.14, Florida Statutes;

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant to

the Constitution and laws of the State of Florida, do hereby issue the following Executive Order, effective immediately:

Section 1.

The Honorable STEPHEN B. RUSSELL, State Attorney for the Twentieth Judicial Circuit of Florida, hereinafter referred to as the "Assigned State Attorney," is hereby assigned to discharge the duties of the Honorable BRUCE H. COLTON, State Attorney for the Nineteenth Judicial Circuit of Florida, as they relate to the investigation, potential prosecution and all matters related to Amanda R. (Wilson) Montenegro.

Section 2.

The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed forthwith to the Nineteenth Judicial Circuit of Florida, and are hereby vested with the authority to perform the duties prescribed herein.

Section 3.

All residents of the Nineteenth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, to the end that justice may be served.

Section 4.

The period of this Executive Assignment shall be for one (1) year, to and including March 30, 2013.

Section 5.

The Assigned State Attorney shall notify the Governor on or before February 28, 2013,
if additional time is required.
