

# STATE OF FLORIDA

## OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 18-184

WHEREAS, the Honorable PHIL ARCHER, State Attorney for the Eighteenth Judicial Circuit of Florida, has advised Governor RICK SCOTT that Alan Roy Worthy has been charged with aggravated battery; and

WHEREAS, the Honorable PHIL ARCHER has also advised the Governor that Alan Roy Worthy is an employee with the Cocoa Beach Police Department and has had a possible social relationship with the defendant and the victim; and

WHEREAS, the Honorable PHIL ARCHER, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney with respect to the investigation and prosecution of this case and all related matters; and

WHEREAS, the Honorable BRUCE H. COLTON, State Attorney for the Nineteenth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable BRUCE H. COLTON discharge the duties of the Honorable PHIL ARCHER, pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, in obedience to my solemn constitutional duty to “take care that the laws be faithfully executed,” and pursuant

to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1.

The Honorable BRUCE H. COLTON, State Attorney for the Nineteenth Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable PHIL ARCHER, State Attorney for the Eighteenth Judicial Circuit of Florida, as they relate to the investigation, prosecution, and all matters related to Alan Roy Worthy.

Section 2.

The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Eighteenth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3.

All residents of the Eighteenth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4.

The period of this Executive Assignment shall be for one (1) year, to and including June 28, 2019.

Section 5.

The Assigned State Attorney shall notify the Governor on or before May 28, 2019, if additional time is required.
